1. Deposit & Payment Terms

1. A **non-refundable deposit of \$200** per participant is required at the time of booking to reserve a spot on any Trip.
2. Final payment is due no later than 30 days prior to trip. Failure to pay the remaining balance by the due date will result in cancellation of the reservation and forfeiture of the deposit and spot.
3. The \$200 deposit is **non-refundable under any circumstances**, including but not limited to illness, scheduling conflicts, or participant-initiated cancellations.

2. Cancellations & Refund Policy

1. Cancellations must be made in writing (via email or letter) to ScubaVentures.
2. Refund eligibility (excluding the non-refundable deposit) is as follows:
 - a. **60+ days before departure:** Refund of all payments made, minus the deposit.
 - b. **Less than 30 days before departure:** No refund and spot forfeiture.
 - c. **If spot is sold:** Refund of all payments made
3. If ScubaVentures cancels a Trip for reasons beyond its control (e.g., weather, minimum participant requirements not met, travel restrictions), participants may receive **a credit toward a future trip**, but **no cash refunds** will be issued.

3. Participant Requirements

1. Participants must hold a valid scuba certification from a recognized training agency unless the Trip includes instruction.
2. Participants must be medically fit to dive and agree to complete a current **medical questionnaire and liability release** prior to participation.
3. Participants are responsible for maintaining valid dive insurance, travel insurance, and passports (if required).

4. Assumption of Risk

1. Participant acknowledges that scuba diving and travel involve inherent risks, including but not limited to equipment malfunction, marine life hazards, decompression sickness, and environmental conditions.
2. Participant voluntarily assumes all risks and agrees to hold ScubaVentures, its owners, employees, agents, and affiliates harmless from any liability, injury, loss, or damage arising from participation in the Trip.

5. Equipment Responsibility

1. Participants are responsible for the care and return of any rented or loaned equipment.
2. Lost or damaged equipment will be charged to the participant at the replacement value.

6. Conduct & Compliance

1. Participants agree to follow all instructions provided by ScubaVentures staff and dive professionals.
2. ScubaVentures reserves the right to remove any participant from a Trip for unsafe, disruptive, or inappropriate behavior without a refund.
